

## Instructions for Completion of the COVID-19 Long-term Care Facility (LTCF) Resident Therapeutics Form ([CDC 57.158](#))

Data Field	Instructions for Form Completion
NHSN Facility ID #	The NHSN-assigned facility ID will be <b>auto-generated</b> by the system.
CMS Certification Number (CCN)-may be referred to as participation number	<b>Auto-generated</b> by the computer, if applicable, based on the CCN entered during NHSN registration or last updated, if previously edited. Please see <a href="#">NHSN CCN Guidance</a> document for instructions on how to add a new CCN or edit an existing CCN.
Facility Name	<b>Auto-generated</b> by the system based on the facility name previously entered during NHSN registration.
Date for which counts are reported	<b>Required.</b> Select the date on the calendar in which the counts are being reported in the NHSN LTCF COVID-19 Module- <i>Therapeutics Pathway</i> .
Facility Type	<p><b>Auto generated</b> based on the facility type selected during NHSN enrollment. Date Created	<b>Auto generated</b> based on the first calendar date and time that a user manually enters and saves data or the date the facility first submits a CSV file for a specific pathway. <b>Note:</b> The date and time will automatically generate after the “Save” button is selected and <b>cannot</b> be modified.

<p><b>Therapeutic</b></p> <p>For each therapeutic listed, enter the number of residents who received the therapeutic at this facility or elsewhere <b>during the current reporting week only.</b></p> <p><b>Important:</b> Do <b>not</b> report cumulative counts.</p> <p><b>CSV Template Variables:</b></p> <p><b>CASIMDEV:</b> Casirivmab/imdevimab (Regeneron)</p> <p><b>BAMETES:</b> Bamlanivimab/etesevimab (Lilly)</p> <p><b>SOTRO:</b> Sotrovimab (GlaxoSmithKline)</p> <p><b>MOLNUP:</b> Molnupiravir (Merck)</p> <p><b>EVUS:</b> Evusheld (AstraZeneca)</p> <p><b>PAXL:</b> Paxlovid (Pfizer)</p>	<p><i>Therapeutic</i> is defined as a treatment, therapy, or drug. Monoclonal antibodies are examples of anti-SARS-CoV-2 antibody-based therapeutics used to help the immune system recognize and respond more effectively to the COVID-19 virus.</p> <p>Since the last date these counts were collected for reporting to NHSN, indicate the number of residents who received one or more of the listed therapeutics, based on:</p> <ul style="list-style-type: none"> <li>• <b>In-house stock</b> that was stored at your facility (specifically, either administered by your LTCF or by an outside entity using stock provided by your LTCF).</li> <li>• Stock that was <b>stored at another facility</b>, such as an infusion center or hospital.</li> </ul> <p><b>Important:</b></p> <ul style="list-style-type: none"> <li>• The reported counts must include only the number of newly administered therapeutics since the last date in which therapeutic counts were reported to NHSN.</li> <li>• If there were no residents who received one or more of the listed therapeutics during the reporting week, a zero (“0”) is to be reported for each listed therapeutic. A blank field could be interpreted as missing data.</li> <li>• Counts include resident(s) who received the listed therapeutic during the reporting week regardless if the therapeutic was administered to the resident while in the LTCF or while in another facility.</li> </ul> <p><b>Example:</b> During <b>this reporting week</b>, a total of <b>7</b> residents received a therapeutic (specifically, were treated with monoclonal antibodies or antivirals).</p> <ul style="list-style-type: none"> <li>• <b>Resident A</b> was transferred to the emergency department where he received an infusion with <i>Sotrovimab (GlaxoSmithKline)</i>, so he was included in the <i>Sotrovimab (GlaxoSmithKline)</i> count in the second column [1].</li> <li>• <b>Residents B and C</b> were treated in their LTCF with <i>Regeneron’s Casirivimab plus Imdevimab (Regeneron)</i> by an infusion nurse who administered the infusions <u>from stock stored at the LTCF</u>, so they were included in the <i>Casirivimab plus Imdevimab (Regeneron)</i> count in the first column [2].</li> <li>• <b>Resident D</b> was treated with <i>Bamlanivimab and etesevimab (Lilly)</i> by an infusion nurse who brought the <u>therapeutic from an outside pharmacy</u>, so the resident was included in the <i>Bamlanivimab and etesevimab</i> count in the second column [1].</li> <li>• <b>Resident E</b> was treated with Evusheld (AstraZeneca) in the facility from stock stored at the facility, so the resident was included in the Evusheld (AstraZeneca) count in the first column [1].</li> <li>• <b>Residents F and G</b> both received Paxlovid (Pfizer) while in the facility from stock stored within the facility. They were included in Paxlovid (Pfizer) count in the first column [2].</li> </ul>
